## How to register a Horse on the FEI Database

In accordance with Art. 113 of the FEI General Regulations, all Athletes and Horses must be annually registered with the FEI to compete in a FEI event.

To register a Horse you must have the necessary access on your account. If you require access please contact: [usersupport@fei.org](mailto:usersupport@fei.org)

**Step 1:** You must go to <https://data.fei.org> and log in with your FEI ID number and password



You click on HORSE and SEARCH to open the HORSE SEARCH window.

**Step 2:** You search for the horse in question, either by Name or FEI ID number:

You will then click on DETAIL to open the HORSE's profile page:

**Step 4:** You tick the box that corresponds to the discipline for which you want to register the Horse.

In an attempt to improve risk management in Eventing, the FEI has added a mandatory release of medical/veterinary information to the registration procedure for Eventing. This release allows the FEI to collect and evaluate medical/veterinary data regarding injury and treatment information of you as an athlete and/or of your horse. This is being done to support the analysis of the exact type of injuries sustained in Eventing, the value of protective equipment, and the quality and nature of medical & veterinary services. All such information will be treated as strictly confidential, and used primarily for production of cumulative statistics which will assist us in continuously improving the risk management of the sport.
