Which pages of the horse's identification document need to be uploaded on the FEI Database?

When certain actions are made on the FEI Database in regards to Horses, certain pages/scans of their identification documents must be uploaded on to the FEI Database.

This is to improve horse identification and traceability at events, during international travel and throughout the horse's career.

| Name Page Nat. Doc | ✓ | Page(s) from the approved national passport containing the name of the horse. <i>(the page must contain the name of the horse, this might not be the front cover)</i> |
| Diagram and Description Page | ✓ | Description and Diagram page(s) of approved national passport <i>(these might be on separate pages, so two scans are necessary)</i> |
| Horse Information Page | ✓ | Page(s) from the approved national document containing basic information about the horse <i>(e.g. Colour, Gender, Date of birth etc.)</i> |
| Pedigree page | optional | Pedigree page from the approved national passport |
| Owner Page Nat. Doc | optional | Ownership page from the approved national passport |
